1. DESCRIPTION

Viking ESFR Sprinkler Guards/Water Shields are used in conjunction with ESFR style sprinklers where allowed by the approvals. (Refer to the Approval Charts) The guard/water shield is a hard-wire cage with an integrated carbon steel plate designed to surround the sprinkler and protect it from mechanical damage as well as water spray from above. The guard/water shield is recommended for areas where sprinklers are installed at a low elevation and/or near a high degree of human or mechanical activity as well as where water shielding is required.






Figure 1: Dimensions

► Follow the procedures in this document to properly install the sprinkler guard/water shield.


Installing the ESFR Sprinkler Guard/Water Shield on the Sprinkler

Tool needed:

#2 R.H. Phillips or Flat Head screwdriver (not available from Viking.)

Procedure:

- 1. Loosen the screw and open the guard/water shield.
- 2. Place the guard/water shield around the sprinkler as shown. Be sure the pins line up with the sprinkler frame as shown.




